Recommendation of the Inspection Team:-

The Inspection team duly constituted by reference to Aryabhatta Knowlwdgw University, Patna vide letter no. 006/Affili/426/AKU/2021 (Vol – II)-2801 dated 13-06-2024 visited Netaji Subhas Institute of Technology, Bihta, Patna on 19-06-2024 (forenoon) and inspected infrastructural and instructional facilities available in the college for the course BCA with intake capacity 60 and BBA with intake capacity 60 for the academic session : 2024-25.

Observation and findings:


The inspection team observed that the college has sufficient infrastructural and instructional facilities for BCA with intake capacity 60 and BBA with intake capacity 60 for the academic session : 2024-25. It is important to be mention here that all infrastructural facilities are located in three different buildings and these are shared by the students of other courses also.


Suggestion:

- (i) The college is suggested to appoint more faculty members in both the courses maintaining the cadre ration as per norms.
- (ii) Licensed version of System and Application software are required to be purchased.
- (iii) The existing library must be exclusively for BCA and BBA students.
- (iv) There must be provision for Common Room facility for Boys and girls separately.

Recommendations:

On the basis of observations and findings, the inspection team recommends that extension of provisional affiliation may be granted to Netaji Subhas Institute of Technology, Bihta, Patna for the course BCA with intake capacity 60 and BBA with intake capacity 60 for the academic session : 2024-25 subject to condition that above mentioned suggestions must be fulfilled before the commencement of the session.
